If the kasambahay cannot provide any identification documents, he/she can still be given the membership numbers, but will be tagged as “Temporary Membership Status” for the purpose of the collecting the contributions. However, the member should submit the required documents to obtain a Unified Multi-Purpose Identification (UMID) Card and enjoy the benefits and privilege of being an SSS member.

To apply for SSS, Pag-IBIG, and PhilHealth numbers, fill out a Kasambahay Unified Registration Form that’s available in any branch of the three agencies. The form may be downloaded online and filled out in advance. Submit the accomplished form to the nearest SSS, Pag-IBIG, or PhilHealth branch.

SSS Kasambahay Registration Procedures

Employers are mandated to have their kasambahays registered as members of SSS, PhilHealth, and Pag-IBIG. Premium payments or contributions shall be shouldered by the employer. However, if the domestic worker is receiving a wage of Php5,000 and above per month, the kasambahay must pay the proportionate share in the premium payments or contributions, as provided by law.

Under the Implementing Rules and Regulations (IRR) of the Kasambahay Bill, SSS, Pag-IBig and PhilHealth have a period of six months from IRR promulgation to set up a unified system of registration and enrollment. The IRR was promulgated on May 9, 2013. This means that by November 2013, we should have a one-stop shop to register for these agencies.

If you’re a kasambahay: Find your monthly deduction for SSS contribution on the EE

column corresponding to your MSC. Taking the example above (MSC of Php 3,500), there should be no salary deduction for SSS contribution since your employer shoulders your entire contribution. But if you’re earning Php 5,000 monthly, for example, your employer should deduct Php 200 from your salary and remit it to the SSS along with your employer’s share.

As a rule, the kasambahay should be registered with the SSS, PhilHealth and Pag-IBig after one month of service. There is no deadline for registration. In fact, the IRR clarifies in Rule IX, Sec. 3 that the kasambahay desk in the barangay hall should accommodate continuous registration by the employers.
